





#### EXAMPLE GUIDANCE AEO AUTHORISATION APPLICATION PROCESS



As completion of an extensive self-assessment questionnaire is the core activity of the AEO authorisation application process, it requires collaboration / commitment throughout the entire organisation to gather and correctly describe the requested information and to implement a transformation if necessary.
